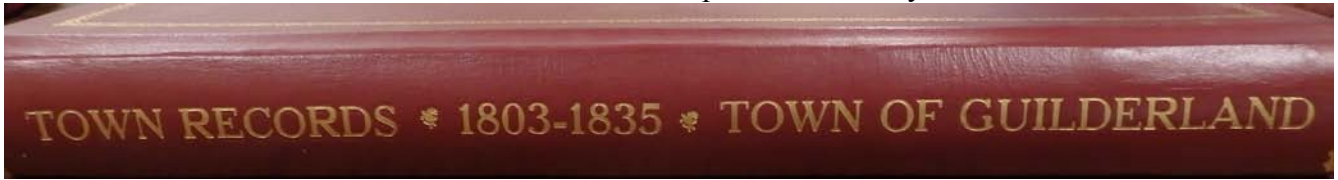


Photographic excerpts from pages of the Town Records of the Town of Guilderland 1803-1835
