At our September meeting, Town Supervisor Peter Barber will make announcements regarding recent activities in the Town, and answer questions from the audience. Biagio DelVillano from Delaware Engineering will provide an update on the stormwater drainage improvement project, and we will summarize information presented at the September 14 meeting hosted by the State Historic Preservation Office regarding the proposed "McKownville-Country Club Highlands" historic district. An election of all officers and three members of our Board of Directors will also take place. Finally, we will invite the audience to make suggestions as to future projects that the Association might work on to improve our neighborhood. For now, due to the surge in cases of Covid-19 in Albany County, we are continuing to hold our meetings online only. Again this month, Delaware Engineering is kindly hosting our meeting via the Zoom platform.

Our next meeting will take place on Wednesday, October 20th. Tim Wiles, Executive Director of the Guilderland Public Library, will tell us about the reopening of the library, and the activities taking place in the expanded space. Candidates for positions on the Town Board will also have time to introduce themselves and answer questions.
