Sidewalks: Town of Guilderland ADA Transition Plan. On Tuesday, October 1, at 7pm, the Town Board will hold a public hearing on the draft [Town of Guilderland ADA Transition Plan](https://www.townofguilderland.org/755/ADA-Self-Analysis-and-Transition-Plan), the result of an 18-month review and the rating of the Town-maintained sidewalks for compliance with the Americans With Disabilities Act. Please note that the document indicates that sidewalks on certain streets in McKownville may be located on privately owned property, and those property owners could have financial responsibilities related to the compliance requirements.
