The remainder of the evening will be devoted to a "Meet the Candidates" segment, during which candidates for Town offices will introduce themselves and answer questions from the audience.

Updates on the McKownville firehouse: On Wednesday, October 25, the McKownville Fire Department will host a public meeting to inform residents about proposed plans for a new firehouse and how the department will operate during the construction period if bonding for the project is approved by residents via a referendum. The meeting will take place at the firehouse, 1250 Western Avenue, beginning at 7:00 p.m. A second public meeting will be scheduled for a date yet to be determined. The firehouse and the department's volunteers play a vital role in our neighborhood and these meetings will provide an excellent opportunity for residents to become informed about the proposal.
