

thence from said point of beginning South 89° 55' 20" East, a distance of 50 feet, more or less, to a point in the land of ALBANY COLLEGIATE INTERFAITH CENTER, INC.; thence North 00° 04' 40" East, a distance of 10 feet, more or less, to a point still in the land of ALBANY COLLEGIATE INTERFAITH CENTER, INC.; thence North 89° 55' 20" West, a distance of 50 feet, more or less, to a point on the division line between the land of ALBANY COLLEGIATE INTERFAITH CENTER, INC., on the east and the land of UNIVERSITY AUXILIARY SERVICES AT ALBANY, INC., formerly Faculty-Student Association of the State University of New York at Albany, Inc., on the west; thence South 00° 04' 40" West along said division line 10 feet, more or less, to the point or place of beginning.

CONTAINING 500 square feet or 0.011 acres, be the same more or less.

Said easement is granted for the purpose of maintaining, using, operating, repairing, and reconstructing the water supply system facilities consisting of a pump house, well, and water line presently existing on the aforementioned parcel of land.

TOGETHER with the right of ingress and egress along, on and within the said right of way for any and all purposes connected with the proper maintenance, use, operation, repair, reconstruction, and patrolling for any of the purposes and uses hereinbefore specified.

TO HAVE AND TO HOLD the said easement and right of way to the party of the second part, its successors and assigns forever.

Provided, HOWEVER, that the party of the second part shall, at its own cost and expense, replant and reseed the said right of way if at any time the uses which the party of the second part have exercised under this easement and right of way disturb the surface or ground condition in any way, and the party of the second part hereby covenants and agrees to keep the subject parcel and the aforesaid water supply system facilities thereon in good condition and repair unless the party of the second part eliminates the aforesaid water supply facilities completely, whereupon, the

above-described parcel will be replanted or reseeded by the party of the second part to the degree necessary to return it to the condition of the surrounding lands of the party of the first part herein.
