A L L that tract or parcel of land situate in the Town of Guilderland, County of Albany and State of New York and known and distinguished as lot No.8 as laid down and represented on a map of sub division of property in Guilderland, Albany County belonging to the heirs of Christian LeGrange deceased, made by W.H.Slingerland & Son, surveyors and on file in Albany County Clerk's office and said lot is bounded and described as follows to wit: Beginning at a point in the most southerly corner of the lot to be conveyed on the line of the lands of William J.
