To all to whom these Presents shall come sendeth Greeting Whereas
by the Consent of the Commisaries at Albany Jan Hendricks Van
Baal hath made Purchase of the Indian Proprietors of the Maques-
of a certain Parcel of Land near Schanectade lying and being by the
Hill or Creeke called by the Indian Name Tauwasoutha otherwise
the Normans Hill the said Land stretching from the Sandy Hills
North West on to an Out Hook of Land the which it also includes
Containeing in Breadth and Length on both sides of the Hill all
the Land as it lies in a Square together with the Wood Land —
Valley or Meadow Ground Hills and Creeks therein included —
the said Indian Proprietors Names who made Sale of the said
Land and sett to their Marks for the Conveyance thereof being —
Canachko, Schaenwino, Canhowadadiu, and Sagodor mechta who
Acknowledge to have Received Satisfaction for the same Now for a
Confirmation unto him the said Jan Hendricks van Baal in his
Possession and Enjoyment of the Premises Know Ye that by vertue
of the Commission and Authority unto me given by his Royall High-
ness I have Ratified Confirmed and Granted and by these presents
doe Ratifye Confirm and Grant unto the said Jan Hendricks Van
Baal his Heires and Assignes the afore recited Parcel of Land and
Premises with all and singular the Appurtenances To have and
to hold the said Parcel of Land and Premises Together with the
Woodland Valley or Meadow Ground Marshes Lakes Hills and —
Creeks within the Limitts of the said Land Included unto the —

per use and behoofe of him the said Jan Hendricks Van Baal
his Heires and Assignes forever Yeilding and Paying therefore Searely
and every Yeare as a Quitt Rent unto his Royall Highness his use
when it shall be demanded by such Officer or
Officers in Authority as shall be empowered and Established from
time to time hereafter to command and Receive the same Given
under my Hand and Sealed with the Seal of the Province at Fort
James in New York this One and Twentieth day of August in the
21st Yeare of his Majesties Reigne Anno Domini 1674. —
