THIS INDENTURE, made the 27th day of June in the year One thousand nine hundred sixteen, BETWEEN John N. Grasser, residing in the City and County of Albany and State of New York, of the first part and Albany Country Club a membership corporation having its principal office located in the Town of Guilderland, Albany County, New York, party of the second part

WITNESSETH that the said party of the first part for and in consideration of three thousand dollars (\$3000) lawful money of the United States paid by the said party of the second part does hereby remise release and forever quit-claim unto the said party of the second part its successors and assigns forever

ALL that certain lot piece or parcel of land situate formerly in the tenth ward of the City of Albany and subsequently in the Town of Guilderland and now partly in the nineteenth ward of the City of Albany and partly in the Town of Guilderland, bounded and described as follows: Beginning at a point of intersection of the south line of Lydius Street sometimes called Madison Avenue with the west line of land formerly owned by Anna T. Hallenbeck and now owned and occupied by the Albany Country Club, being a point at the northeast corner of Lot No. 16 as shown on a map of twenty seven lots west of Magazine Street formerly in the City of Albany and running thence southerly along the line of said land formerly of Hallenbeck now of the Country Club

sight (8) chains eighty one (81) links to other property of the Albany Country Club formerly owned by Benjamin G. Hendrickson thence westerly and along the property of said Country Club four (4) chains fifty four (54) links thence northerly and along other property belonging to said Albany Country Club eight (8) chains eighty one (81) links to the south line of Lydius Street sometimes called Madison Avenue and thence easterly along said south line of Lydius Street four (4) chains fifty four (54) links to the place of beginning


