its successors and assigns forever, all that certain piece or parcel of land, situate, lying and being in the Town of Guilderland, County of Albany and State of New York, bounded and described as follows:

BEGINNING at a point where the northeasterly bounds of a Paper Street to have been named either Mercer Street or Warren Street intersects the City and Town Line (City of Albany on the northeast and Town of Guilderland on the southwest) and running thence from said point of beginning South 51 degrees 58 minutes 30 seconds East along said northeasterly bounds of the Paper Street, in part along the southwesterly bounds of a triangular shaped parcel of land of the party of the first part and in part along the southwesterly bounds of Lot 119 and 118 of lands of the party of the first part as shown on a map entitled "Garden Park Estates" - Extension, and in part across a Paper Street to have been known as Ann Street 323.8 feet to a point in the southeasterly bounds of said Ann Street (Paper), thence South 38 degrees 01 minutes 30 seconds West across the intersection of said Mercer or Warren and Ann Streets (Paper) 19.9 feet to a point of curvature of a curve having a radius of 80.0 feet, an arc length of 105.33 feet and subtended by a chord which deflects 45 degrees 00 minutes 00 seconds to the right from the described course extending North 83 degrees 01 minutes 30 seconds East 97.88 feet to a point in said intersection, thence North 51 degrees 58 minutes 30 seconds West in part across said intersection of Mercer or Warren and Ann Streets (Paper) and in part along the southwesterly bounds of said Mercer or Warren Street (Paper) 266.3 feet to a point, thence North 38 degrees 01 minutes 30 seconds East 60.0 feet to the point or place of beginning, containing 0.39 of an acre be the same more or less.

And also, all that certain piece or parcel of land, situate, lying and being partly in the City of Albany and partly in the Town of Guilderland, County of Albany and State of New York, bounded and described as follows:

BEGINNING at a point where the southwest bounds of Lot 148 and the northeast bounds of Lot 118 intersects the northwesterly bounds of a Paper Street to have been known as Ann Street as shown on a map entitled "Garden Park Estates" - Extension and running thence from said point of beginning South 51 degrees 58 minutes 30 seconds East across said Ann Street (Paper) 60.0 feet to a

point in the southeasterly bounds of Ann Street (Paper), thence South 38 degrees 01 minutes 30 seconds West along said southeasterly bounds of Ann Street (Paper) and along the northwest bounds of Lot 117 as shown on said map and crossing the City and Town Line (City of Albany on the northeast and Town of Guilderland on the southwest), 150.0 feet to a point where said Ann Street (Paper) would have intersected the northeasterly bounds of a Paper Street to have been known as either Mercer Street or Warren Street, thence North 51 degrees 58 minutes 30 seconds West along the last mentioned intersection 80.0 feet to a point of curvature having a radius of 20.0 feet, an arc length of 31.42 feet and subtended by a chord which deflects 135 degrees 00 minutes 00 seconds to the right from the described course extending South 83 degrees 01 minutes 30 seconds West 28.28 feet to a point in said northwesterly bounds of said Ann Street (Paper), thence North 38 degrees 01 minutes 30 seconds East along said northwesterly bounds of said Ann Street (Paper) and crossing said City and Town Line 130.0 feet to the point or place of beginning, containing 0.21 of an acre be the same more or less.

All bearings refer to true North.

BEING a part of the same premises conveyed to William W. Farley, by deed dated December 24, 1946 to Esther Farley McKenna, and recorded December 30, 1946 in the Albany County Clerk's Office in Book 1048 of Deeds at Page 30.
