WITHESSETH that the said parties of the first part in consideration of the sum of three thousand dollars to them only paid have sold and by these presents do grant and convey to the said party of the second part, his heirs and assigns ALL that certain lot of land situate in the said City of Albany, west of Magazine Street, known and distinguished on a map of the same made by Evert Van Allen and filed in the Clerk's Office of the city and county of Albany on the thirteenth day of September 1817 as lot number twenty (20) and bounded as follows; on the north by Lydius Street sixteen chains on the east by lot number nineteen (19) on a line parallel with Magazine Street, thirty five chains and ninety links on the south by the City line sixteen chains and on the west by lot number twenty one (21) thirty five chains and ninety links Containing fifty seven acres and four tenths of an acre of land.
