

John McKown deeds 1860

THIS INDENTURE, made the twenty third day of April in the year of our Lord one thousand eight hundred and sixty. BETWEEN John McKown and Catherine his wife, of the town of Guilderland, County of Albany State of New York of the first part, and James F. McKown of the town, County & State aforesaid of the second part. WITNESSETH that the said parties of the first part, in consideration of the sum of Five thousand dollars to them duly paid, have sold, and By these Presents, do grant and convey to the said party of the second part his heirs and assigns, ALL that certain farm or piece of land situate, lying and being in the said town of Guilderland, bounded as follows, to wit: Beginning at a white pine sapling in the line of lands formerly owned by William McKown, now deceased, and runs thence along Bettys line south forty eight degrees forty five minutes east thirty two chains & forty links to a post, then south fifty four degrees west forty three chains and sixteen links, then north forty five degrees thirty minutes west forty four chains and five links to the place of beginning, containing one hundred and forty three acres and one quarter of land, ALSO that other piece or parcel of land situate lying and being in the town of Guilderland aforesaid, and bounded and described as follows, to wit: on the south by the aforesaid described premises known as the Ross Farm, on the east by a lot formerly belonging to Peter Hilton, now deceased, and now owned by James F. McKown, the party of the second part, on the north by the Great Western Turnpike, or Plank Road, and on the west by the road that leads from the Western turnpike to the afore said described premises, containing twelve acres of land be the same more or less, the last mentioned and described premises is what is commonly known as the first parcel of the Gore.

[With the appurtenances, and all the estate, title and interest] therein of the said parties of the first part. And the said John McKown for himself & his heirs doth hereby covenant and agree to and with the said party of the second part, his heirs and assigns, and the premises thus conveyed in the quiet and peaceable possession of the said party of the second part his heirs and assigns and will forever warrant and defend against any person whomsoever lawfully claiming the same, or any part thereof. IN WITNESS WHEREOF, the parties of the first part, have hereunto set their hands and seals the day and year first above written.
