*To the Board of Supervisors of the County of Albany, New York:*

We, the undersigned, proposing to maintain a chemical engine for the prevention and extinguishment of fires in the district hereinafter described, and being taxable inhabitants whose names appear upon the last preceding assessment-roll and who own or represent more than one-half of the taxable real property owned by the residents of that territory of the Town of Guilderland, Albany County, lying outside the limits of an incorporated village or city, bounded and described as follows:

Beginning at the center of the creek at the north side of the Great Western turnpike, near the entrance to the Albany Country Club, and running southwesterly along the Albany City line to its intersection with the Beatty line; thence northwesterly along said Beatty line to the corner of the McKown-Ross farm; thence southwesterly along the line of William McKown to its intersection with the Pitkin-Whitbeck line to the east line of the Schoolhouse road; thence northerly to the south line of the Great Western turnpike; thence easterly along the south line of the Great Western turnpike to its intersection with the center of the Krummykill; thence northerly along a line parallel with the Fuller road to the intersection of said line with the Albany City line; thence along said Albany City line in an easterly direction to the point of beginning;

do hereby petition your honorable body, in pursuance of subdivision 1 of section 38 of the County Law, that such territory be established and constituted a fire district of the Town of Guilderland, Albany County, New York, as provided by said subdivision 1 of section 38 of the County Law.
