Regarding a regular meeting with a CESTM / Nano-tech representative - I'd be willing to give this a try if the meetings were held somewhere in that complex so that I could get there and back during a workday without losing too much time.

I'm planning on making the Thruway meeting on March 14th - with the caveat that things can pop up with the kids that might prevent me from doing so. But I've got it on the calendar ahead of anything else and that is half the battle.

For the March 9 meeting I think we need to follow through with a formal, written summary on the 'brainstroming' that we did in the February meeting. I think we want to have a document that we can point to that reminds anyone who might question us that we sought out, and got, real input from the community as to what it wants McKownville to be. I think we should hand it out to the attendees at the March meeting with a little bit of flourish.

Having said that, I realize that it is not a small undertaking to put such a document together. I'd be willing to help with editing and proofing something like that, but I don't think I have the time to author the first draft. But if we can't have it ready for the March 9 meeting, I do think we should try hard to have something by April, before it is forgotten.

Regarding the McKown Rd sidewalk, I think Don C. is best equipped to give an update on that but if he is not going to be there I will do it. I'll send him an e-mail and ask if he is going to be present and, if not, if he could relay the current status to me so I can speak about it.

Finally, I am very interested in knowing who at town hall has oversight responsibility for the project that is to be funded by the CDTC-TIP grant. Do you know who that is? It seems to me that something should be moving on that by now but I haven't heard of anything as yet. I think it is important for the Association to know who we should be talking to at Town Hall to learn the status and to be involved in the early stages to avoid any nasty surprises. That money is not going to go as far as we would hope so I want to make sure it is used on what WE consider the priorities.
