There are construction trucks on Loughlin Street today. People and machines are digging up lawns. Tanks are being removed. **PSI (518-377-9847, 104 Erie Blvd, Schenectady)**--Paul Miasiaszek is the environmental manager for the project. He informed me that he was "**forbidden to tell anyone about who is paying for the work**". The present job is to remove buried tanks.

To keep the 1000 families that live in the neighborhood informed about what is happening to the dozen or so (now vacant) homes on Loughlin Street is not very much to ask of SUNY POLY (and its governing board). SUNY POLY may not own the property but it knows what is happening, who is doing it, and what the plans are.

If that is not possible to keep us informed, would you tell us when the next governing board meeting of SUNY POLY is so the neighborhood can ask them.
