There will be four sets of speakers at our April meeting. Assemblymember Patricia Fahy will summarize highlights of the recently passed NYS budget and answer questions from the audience. Representatives from Delaware Engineering will update us on the stormwater and drinking water projects. Bill Krattinger from the New York State Historic Preservation Office (SHPO) will speak to us on the status of the nomination to include a portion of Western Avenue, Waverly Place, and the southern portions of Norwood, Glenwood, Parkwood and Elmwood Streets on the National and State Registers of Historic Places. Last year our neighbors Susan Anderson and Bill Kidd completed a great deal of research to identify early owners and construction dates for the homes that will be included in the historic district if the project goes forward. They will show us how they went about the research, using their own home on Elmwood Street as a case in point.

## Other News:

At last month's Association meeting Travis Smigel announced that Delaware Engineering has assigned him to another project. The new project manager is Biagio Del Villano; George Zimmer is the lead project inspector. Construction work on the CoreLife restaurant building on Western Avenue to the west of the University entrance continues. Site work has begun for the construction of 252 apartment units (seven five-story buildings) along Fuller Road and Sandidge Way. Trees have been destroyed and we anticipate that demolition of the houses on Sandidge Way will soon follow.

The McKownville Fire Department has been working to update the design and bid specifications for the fire station's renovation. When a new estimate and timeline is received from Delaware Engineering a public hearing and vote on the project will be held.
