At a meeting of the board of directors of the McKnwnville Improvement Association, held November 17, 1925, several members of the board stated that they had heard many complaints from the residents of this community regarding transfers not being granted to passengers boarding a trolley within the area between State and Pearl Sts. and Washington Ave. and Lark St. to the Western Ave. buses at Manning Boulevard. complaints were based on the fact that during the evening rush hours it is impossible to board the buses within this area, and frequently as many as five buses will pass before they are able to get on one. They would be willing to board a trolley car in this area and transfer to the bus at Manning Boulevard, but under your present system of issuing transfers they cannot secure one to transfer to the bus at that point. seems to us an unnecessary hardship imposed on the people of this community, especially in inclement weather, and we would respectfully request that you consider this condition and ascertain if it would not be possible to issue transfers from the trolley cars to the buses to those who are obliged to depent on your service to take them home.

We are all pleased with and appreciate the service the new buses are giving us at all other times, and we know that you will grant us the privilege of transfers as above requested if it is at all practicable for you to do so.
