MINUTES OF MEETING

September 30, 1963

A special meeting was called to be held at the home of the President at 7:45 P.M. on September 30. The following officers were in attendance:

The matter of storm drainage on Hillcrest Avenue was presented and discussed. An informal map showing the work accomplished under the Quadrini Motel was viewed by the members present. The map also showed the piping area approved for laying from the Quadrini Motel to the Krumkill Stream. The present point of discussion was whether or not the Association should urge the Town Board to take prompt action now needed for a 42" pipe line to run from the Hillcrest Avenue manhole to the manhole at the south-west corner of the Motel. The seriousness of the condition was discussed and it was unanimously agreed that a letter should be sent to the Town Board requesting that appropriate steps be taken to have at least this part of the storm sewer system also corrected at this time. It was agreed to also have the letter state that if sufficient funds in the McKownville Sewer District are available that consideration might be considered for its use.

A letter from the Commissioner of the New York State Motor Vehicle Bureau was read which concerned traffic lights on Western Avenue in McKownville. The letter was in reply to one having been written by Mr. Guy Rising. The Commissioner's letter was turned over to the McKownville Improvement Association for information of what the State planned to pursue. Since this is an old chestnut and inasmuch as Mr. Rising is now ill and will questionably be able to pursue the matter

individually, the Association agreed to have a follow-up letter prepared to give impetus to the matter and request the State study include consideration of modern type lights with timers so that the lights would only be in operation the necessary part of the day (i.e., 7:30 A.M. to 6:00 P.M.). Wm. Reynders to draft letter for President's signature.

The members thought it would be a splendid idea to send Mr. Rising a card from the Association wishing him well. (Mr. Gerald Hamme will-so do.)

It was agreed that the next meeting of the officers and directors would be held on November 18 at 7:45 P.M. at the home of the President, 30 Norwood Street. It was also suggested that a notice of that meeting should be made in the Turnpike Record to encourage the people of the Association and McKownville in general to bring any pertinent matter to the attention of the members for service by the Association. (Mr. Hamme will prepare notice.)
